**CALL MEETING TO ORDER**: Dr. Zumwalt, Chairman, called the Iroquois County Public Health Department Board of Health Finance Committee meeting to order at 4:30PM on Wednesday, June 4, 2025, in the Iroquois County Public Health Department Administration Office. Roll call was taken.

**APPROVE AGENDA**: Lyle Behrends made a motion to approve the agenda. Motion seconded by LuAnn Armantrout and approved by voice vote.

**REVIEW AND APPROVAL OF CLAIMS FOR MAY 2025**: A claims listing for May 2025 was reviewed for approval. Lyle Behrends made a motion to approve the May 2025 claims as submitted. Motion seconded by LuAnn Armantrout and approved by roll call vote: Aye – Dr. Zumwalt, Lyle Behrends, and LuAnn Armantrout.

**GRANTS & CONTRACTS LIST**: A grants & contracts list for May 2025 was distributed for review. Robin explained that the comprehensive health protection grant for FY 2026 was submitted and finalized. To conclude, Robin shared that the Respiratory grant may not be available next year and would exclude it from the FY 2026 budget.

ICPHD PROGRAM UPDATE – MAY 2025: A copy of ICPHD's program summary report was distributed for review and discussion. Robin Allen began by sharing that an Iroquois county resident passed away from Legionnaires' disease during the month of May. In Environmental Health, 15 temporary food permits were issued, 6 mosquito trap specimens were collected, 6 private sewage inspections were completed, and 7 radon kits were distributed. Additionally, 46 childhood immunizations, 19 adult immunizations, and 3 TB tests were administered. Furthermore, 2 health fairs were attended, 13 Narcan trainings were completed, and 1 CPR training was conducted. To conclude, Robin provided an employment update in regard to the Senior Services department.

**ICPHD ADMINISTRATOR COMMENTS – ROBIN ALLEN:** ICPHD Administrator, Robin Allen, shared that the Vermillion County WIC office would begin serving Iroquois County in the coming weeks.
